

CITY OF ROANOKE RAPIDS
Financial Report
April 30, 2011

This report is to be used for informational purposes only and is only a snapshot of the City's general ledger as of the last day of each month. During the month of April, the Finance Department issued 66 purchase orders, wrote 541 payroll checks and 329 accounts payable checks. \$267,410.50 was collected by the Revenue-Tax Division. The attached operating statement shows the results of operations for the current fiscal year.

General Fund

Operating revenues and expenditures through April as reported by the Finance/Tax Division:

- **General Fund operating receipts** totaled \$11,652,453.12. (The percentage of actual money collected of adopted budgeted figures stand at 77.1%)
- **General Fund operating expenditures** totaled \$11,732,949.21 (The percentage of actual monies expended of adopted budgeted figures stand at 77.6%)

As shown on the attached operating statement, *year to date expenditures exceeded revenues by \$80,496.09.*

- **The monthly cost associated with the 2007 Series Bonds** totaled \$79,933.29.
 (Breakdown – \$70,417.65 swap payment; \$7,855.64 Letter of Credit fees and \$1,660.00 commission/wire fee)
- **Sales and Use Tax receipts for the month** totaled \$143,074.35. Our adopted 2010 / 2011 budget for this category is \$2,249,778.00. The percentage of actual money collected of adopted budgeted figures stand at 53.3%. (Down 8.9%)
