EXEMPT – City License Taxes Prohibited by NC General Statutes

Effective July 1, 2015 the North Carolina General Assembly passed **House Bill 1050** which eliminated the authority of municipalities to levy a business license tax with the exception of beer and wine, limousines and taxicabs.
